

Terms & Conditions & Frequently Asked Questions

What is the aim of the scheme?

Privilege Points reward registered clients with Gift Vouchers when they place conference and event business through Obis 360. These vouchers enable them to choose an exciting activity or experience for themselves or their family and friends.

How do I register?

This scheme is by invitation only, to join companies must register by completing the form found online www.obis360.com/privilegepoints and sending it to privilegepoints@obis360.com or fax +44(0)207 095 9972.

In completing the application form you are agreeing to the terms and conditions of the scheme

How does the scheme work?

One Privilege Point will be awarded for every £150.00 excl VAT of qualifying conference and events business confirmed through Obis 360.

Qualifying conference or events business is that which Obis 360 will earn commission from. Events business that is booked through Obis 360 that is non-commissionable will not qualify for Privilege Points.

Points are allocated once full event account has been closed (either direct to the venue or with Obis 360) and added to your Privilege Points Account at the end of each month. Privilege Points can be redeemed against a range of Activity vouchers. (Details can be found at www.obis360.com/privilegepoints).

You will receive quarterly statements but you can find out your balance any time by sending a request to privilegepoints@obis360.com detailing your membership number.

Are there any special conditions relating to the booking?

The booking value must be of a minimum value of £500 excl VAT per booking.

The booking must qualify for the scheme as per the details above.

If you confirm one of Obis 360's Additional Services these do qualify for Privilege Points. These Additional Services are defined as:

Event Management, Production/Programme Development & Speaker Acquisition, Delegate Management, Marketing & Promotion, Delegate Acquisition, Response Management, Registration Websites, Badge Production and On-Site Electronic Tracking

Claims will not be accepted for bookings or enquiries made before date of entry to the scheme.

Can I earn extra Points?

From time to time we will have special promotions for double points. If you place new business during one of those periods you will gain 2 points for every £150.00 excl VAT spend on a qualifying event.

The points that are advertised at the time of the initial enquiry are the points that are rewarded, point levels may change as demand fluctuates, so check the website on a regular basis.

How do I redeem my Privilege Points?

Privilege Points can be redeemed by completing the Privilege Points Claim form and returning this to points@obis360.com or by fax to +44 (0)207 095 9972. (Forms can be found at www.obis360.com/privilegepoints or requested to be sent by email)

The voucher of your choice will then be issued within 28 days and the voucher is valid for 10 months. With the voucher you are then free to select from a range of different experience.

Once you have selected which experience you require (this will be done online), you will be issued with your confirmation details and guidelines. All that is left for you to do is choose the date and/or location (to be with 10 months of voucher issue date).

How long will my Privilege Points stay on my account?

Your points will remain on your account until 31st December 2011. All claims and redemptions must be made before this date.

Will I receive other promotional offers?

By registering you are granting Obis 360 Ltd permission to contact you with news and special offers that we think would be of benefit to you. We will not pass your details on to any third party, but if you want to be removed from any mailing lists just let us know by emailing privilegepoints@obis360.com

Are there any other general terms and conditions I should be aware of?

There is a minimum claim amount of 25 points.
